		<p>Patients are advised that prices are subject to change without notice, and the packages cannot be combined with any other offers or promotions. No exchange or substitution of a package is permitted, nor can services from a package be redeemed for cash.</p> <p>As part of an initial first consultation, CarefulTrip will quote patients the cost of a treatment, and the quote will be valid for 30 days. During a face-to-face consultation and subsequent pre-treatment medical examination, any unforeseen costs will be declared to patients. Patients must pay Careful Trip for the total cost of the procedure or treatment before the operation can proceed.</p> <p>Patients are advised that CarefulTrip will apply for a visa on their behalf in order to allow travel to Iran. Careful Trip gives information it collects from patients to other parties such as the Ministry of Foreign Affairs (MFA), the Ministry of Intelligence of Iran, and the travel agencies only to process visas.
